Partner with local churches, organizations and individuals in serving our local community.



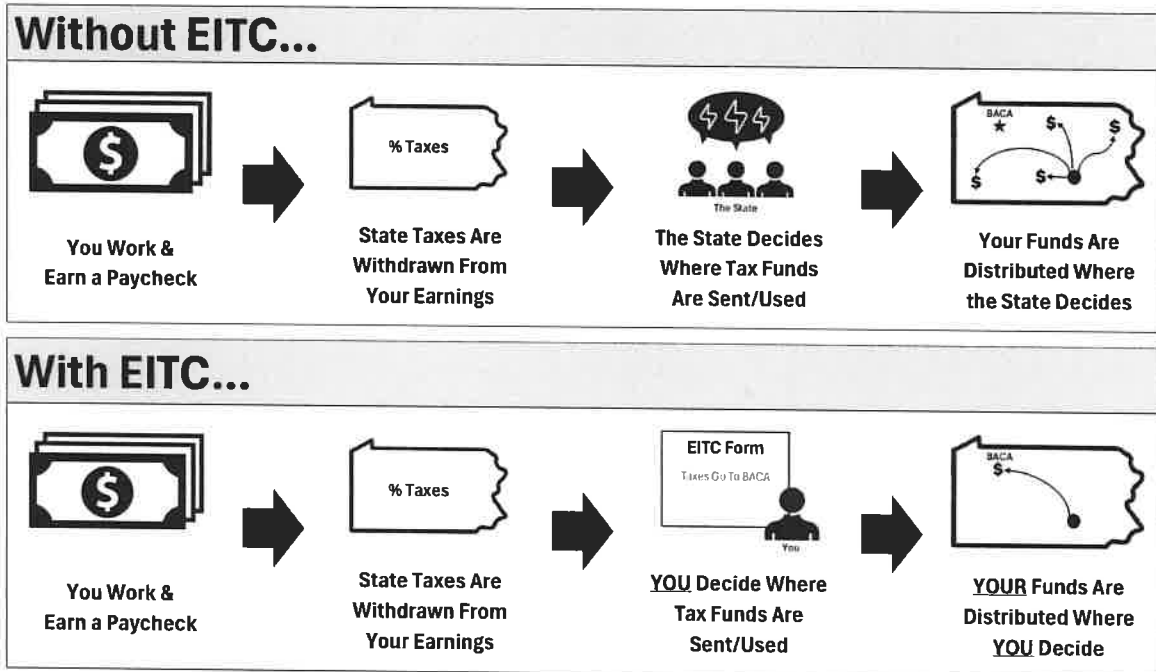
The Educational Improvement Tax Credit (EITC) Children's Scholarship Program

Would you like to make a positive impact in a child's life? Would you like to see your giving to help children grow 1,000%? Would you like to keep your PA tax dollars in your local community? Would you like to support Christian education? If you answered "yes" to any of these questions, then we have an incredible opportunity for you.

Pennsylvania is one of only a handful of states that allows you to "redirect" your PA tax dollars to children scholarships. These are PA tax dollars you already have to send to Harrisburg, PA so there is minimal or no cost to you. For over two decades the families of BACA have greatly benefited from the EITC (Educational Improvement Tax Credit) Children's Scholarship program. This program helps to reduce the cost of tuition for parents, and allows more children to attend the school.

Frequently Asked Questions (FAQ)

Taxes That May Qualify

- Personal Income Tax
- Bank Shares Tax
- Capital Stock Tax
- Insurance Premiums Tax
- Corporate Net Income Tax
- and more

Timeline

- Winter / Spring: Determine if you, your spouse or your business qualify.
- Winter / Spring: Complete your application as early in the year as possible.
- Spring / Summer: Sign the agreement.
- Summer / Fall: Send in the amount of funds you said you would contribute.
- Winter / Spring: Receive your tax forms and claim your tax credit.

Disclaimers

- 90% tax credit (grades K-12).
- 100% tax credit (pre-school).
- Sometimes a small administrative fee (5% or so) is charged
- Application is only one page long.
- Taxes from government or non-profit organizations may not qualify.
- In most cases, if PA taxes qualify from one source, all of your PA taxes qualify.
- Please check with your tax advisor on your eligibility.
- Minimum \$1,000 contribution required.
- Maybe a two year commitment.
- Meeting all criteria does not guarantee you will be accepted. First come basis.
- Be sure to bookmark all email addresses.
